Re: Order Approving Extension of Ground Water Management Plan - Big Wood River Ground Water Management Area

The purpose of this letter is to notify you that on December 20, 2024, the Director of the Idaho Department of Water Resources ("IDWR") signed an *Order Approving Extension of Ground Water Management Plan*, In the Matter of Management of Ground Water Within the Big Wood River Ground Water Management Area ("Order").

A copy of the Order, Extension of the Final Big Wood River Ground Water Management Area Management Plan, January 1, 2025 – December 31, 2027, and a Certificate of Service for mailing of this notice can be found on IDWR's website at: https://idwr.idaho.gov/water-rights/groundwater-management-areas/big-wood-ground-advisory-committee/ (go to Water Rights → Ground Water Management Areas → Big Wood Advisory Committee → Documents & Resources → BWRGWMA Extended Management Plan – December 20, 2024)

A copy of this notice has been sent to all holders of groundwater and surface water rights that are administered by Water District 37 (Big and Little Wood River basin, including Silver Creek) and Water District 37B (Camas Creek basin).

Any person who is aggrieved by the Order shall be entitled to a hearing before the Director to contest the Order. The person shall file with the Director within fifteen (15) days after receipt of written notice of the order, or receipt of actual notice, a written petition stating the grounds for contesting the Order and requesting a hearing. See Idaho Code § 42-1701A(3).
